**TO:** Town of Peterborough Board of Selectmen, and all personnel needed to carry out proposed administrative inspection warrant.

Proof of affidavit having been made this day before the undersigned Justice of the 8th Circuit Court - Jaffrey District Division by *Scott Surdick on Timothy Herlihy* Town of Peterborough, that there is probable cause for believing that statutory authority for the issuance of an inspection warrant exists for the place, dwelling, structure, premises, vehicles, or records located at 595 Jaffrey Road, Peterborough, New Hampshire.

We therefore command you in the daytime to make an immediate inspection of 595 Jaffrey Road, Peterborough, New Hampshire, the building, property and any appurtenant structures for the following purpose: to determine the extent of violations of the Peterborough Town Code, the State Building Code, RSA 155-A:7, and RSA chapter 482-A that have occurred on the property located at 595 Jaffrey Road in the Town of Peterborough, as well as to determine the extent of the corrective action necessary to remediate said violations and whether any other violations of the Peterborough Town Code or State law have transpired. This inspection may include surveying of the subject property's boundaries, taking of photographs and videos, including taking said photographs and videos with the assistance of a drone, records, measurements, and statements. This inspection may also include testing and taking samples to determine the existence of any soil contamination, hazardous or toxic substances, or unpermitted filling of wetlands on the subject property.

Officers of the Peterborough Police Department shall also enter into the subject property upon receipt a report of shooting at the subject property for the purposes of inspecting the subject property and determining whether any further violations of the Peterborough Town Code or State law are occurring on the subject property or determining whether the owner of the subject property is complying with the Notice of Violation/Cease and Desist Order issued by the Town of Peterborough Code Enforcement Officer on June 25, 2018.

Officers of the Peterborough Police Department are authorized to order the cessation of the use of firearms or any weapons on the subject property and to *seize* any firearms or other *limited* weapons into the custody of Peterborough Police Department for the *duration* of the execution of the Administration Inspection Warrant. *for the safety of all parties involved.*

Timothy Herlihy and all personnel needed shall execute and make

return of this warrant on or before August 3, 2018, good cause having been shown to reflect that an extension of the seven (7) day time period set forth in RSA 595-B:4 is in the public interest.

This warrant to inspect, 595 Jaffrey Road is limited as follows:

and if any violation of state law, or municipal ordinance are found, to bring the responsible person before 8th Circuit Court - Jaffrey District Division or any other court with jurisdiction over the observed violations.
