STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Twenty One*

AN ACT                    relative to medical freedom in immunizations and establishing a committee to examine the policy of medical intervention including immunizations.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1            131:1 New Section: Communicable Disease: Medical Freedom in Immunizations. Amend RSA  
2 141-C by inserting after section 1 the following new section:

3            141-C:1-a Medical Freedom in Immunizations.

4            I. Every person has the natural, essential, and inherent right to bodily integrity, free from  
5 any threat or compulsion by government to accept an immunization. Accordingly, no person may be  
6 compelled to receive an immunization for COVID-19 in order to secure, receive, or access any public  
7 facility, any public benefit, or any public service from the state of New Hampshire, or any political  
8 subdivision thereof, including but not limited to counties, cities, towns, precincts, water districts,  
9 school districts, school administrative units, or quasi-public entities.

10           II. Paragraph I shall not:

11           (a) Limit the commissioner's authority to order treatment pursuant to RSA 141-C:15 or  
12 RSA 141-C:18, nor to order quarantine pursuant to RSA 141-C:11 or RSA 141-C:18.

13           (b) Supersede the requirement for vaccination as a prerequisite for admission to a school  
14 or child care agency pursuant to RSA 141-C:20-a, II.

15           (c) Supersede the involuntary emergency admission process pursuant to RSA 135-C:27-  
16 33; the revocation of conditional discharge process under RSA 135-C:51; or involuntary treatment of  
17 patients compliant with RSA 135-C:57, III.

18           (d) Limit treatment authorized by a guardian over a person; or short term treatment of a  
19 personal safety emergency declared by a licensed physician or nurse practitioner in a psychiatric  
20 care setting, or authorized by a surrogate decision maker or durable power of attorney for health  
21 care delegated by the person while competent to make decisions for them during periods when they  
22 are not competent, pursuant to RSA 137-J.

23           (e) Apply to county nursing homes, the New Hampshire state hospital, or any other  
24 medical facility or provider operated by the state of New Hampshire or any political subdivision  
25 identified in paragraph I.

26           III. The department of corrections may mandate medical treatment or immunization for  
27 inmates when a direct threat exists as defined in 28 CFR section 36.208.

28           131:2 Committee Established. There is established a committee to examine the policy of  
29 medical intervention including immunizations.

1           I. The members of the committee shall be as follows:

2                 (a) Two members of the senate, including one member of the minority party, appointed  
3 by the president of the senate.

4                 (b) Four members of the house of representatives, including 2 members of the minority  
5 party, appointed by the speaker of the house of representatives.

6           II. Members of the committee shall receive mileage at the legislative rate when attending to  
7 the duties of the committee.

8           III. The committee shall examine the policy of medical intervention including  
9 immunizations.

10           IV. The members of the committee shall elect a chairperson from among the members. The  
11 first meeting of the committee shall be called by the first-named senate member. The first meeting  
12 of the committee shall be held within 45 days of the effective date of this section. Four members of  
13 the committee shall constitute a quorum.

14           V. The committee shall report its findings and any recommendations for proposed legislation  
15 to the president of the senate, the speaker of the house of representatives, the senate clerk, the  
16 house clerk, the governor, and the state library on or before December 1, 2021.

131:3 Effective Date. This act shall take effect upon its passage.
