SENATE BILL **55-FN-A**

ANALYSIS

This bill appropriates \$25 million for the Cannon Mountain tramway from the fiscal year 2023 surplus.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 Appropriation; Cannon Mountain Tramway. The sum of \$25,000,000 for the fiscal year ending
- 2 June 30, 2023 is hereby appropriated to the department of natural and cultural resources for the
- 3 maintenance and operation of the tramway at Cannon Mountain. The governor is authorized to
- 4 draw a warrant for said sums out of any money in the treasury not otherwise appropriated.
- 5 2 Effective Date. This act shall take effect June 30, 2023.

METHODOLOGY:
