I did a quick search on GraniteGrok and if you search Windham election, you get 41 articles. If you search Windham incident, you get 85 articles. Obviously, some of those are going to be the same. And if you search Windham audit, the audit tied to the incident,

You get 19 articles. So we have a small amount of history and we have video. have, if you're interested listeners and watchers, search any one of those and you will find not only the hard work these gentlemen have done to try to ensure some level of election integrity in the town of Wyndham, which also means your town wherever you are, because if you know anything about politics, if it's happening there, it's happening where you live. So.

This has been going on for four years now, right? And some number of elections, town elections, federal elections, state elections, and they still can't get anything right.

Tom Murray (01:54.503)

Yeah, I mean, it's laughable, but it's not because it's your election, but it's past the point of ridiculousness and it's gone into like bizarro world. And you can't believe that we've had not one, not two, but three monitors assigned by the attorney general's office.

Ken (02:19.287)

So let me just jump in there just for a second, Tom. According to former Secretary of State Bill Gardner, who served 45 years, the appointment of an election monitor is a very rare occurrence in New Hampshire. It has happened three times in Windham, three. Okay, let that sink in.

Not the kind of record you want to be proud of when you live in a community that you've had the dubious distinction of having three monitors appointed to your elections because they just can't get it right.

And so in 2020, obviously was the big deal. There were several hundred votes that sort of just disappeared and reappeared. And then you had problems with your town election, you problems in the midterms. And now this time you had monitors again and the problem wasn't just the people running the elections. It was also the monitors, yes?

Correct.

Ken (03:22.551)

Right. And this isn't the only time that the monitors did not do their jobs properly. The first time the monitor, who was that? Gene Van Lone?

Tom Murray (03:34.003)

Jane Van Lone, think he was on election, he was a ballot law commission member.

Ken (03:40.853)

He was until we raised complaints and pointed out all of the issues and he resigned from that position. So I'd like to take some credit for that.

Tom Murray (03:47.101)

quickly exited.

Steve (03:54.703)

And what was it? Let's talk about that just for a little minute. So Election Law Commission, people who aren't from New Hampshire might not know what that is. We have one and it doesn't really do anything. Correct?

Ken (04:07.009)

Yeah, about law commission.

Tom Murray (04:08.787)

Yeah. And I would, so the legislature, um, delegate, this is a controversy in and of itself, Steve, because there's a lot of people that think this is a unlawful expansion of the undelegated powers by the legislature given to the ballot law commission, because what

they're supposed to do and what they do do are two different, distinctly different things. They're supposed to be, um, nothing more than

ALRA commission. And what is their job?

an extension for recon purposes. But what they do do is they act more or less as the judge, jury, and executioner in the sense that they weigh heavily in on election matters that many feel as though that's not their pure view. It's basically undelegated expansion of delegated powers.

It's seven o'clock.

to a non-judicial committee and they act in three capacities, an executive function, a judicial function, and to some degree they're almost in a legislative function as well in how they operate.

Yeah, you know, they're also set up to be the group of people who actually evaluate and approve which election machines will be used in New Hampshire. Nobody on that commission, nobody has the technical expertise to make those decisions. And yet they're the ones who are authorizing the use of specific machines. It's a sad statement.

It is. It is.

Steve (05:47.919)

And we've had, see, I take myself, I'm still learning how to use all this equipment I have sitting in front of me. We've written so many articles about LSH and all the people who were involved with elections in New Hampshire, some of the connections to first families, political first families in the state, and the equipment itself. And of course, we continue to have issues and.

Every time, I don't know, maybe I'm wrong, as anybody in the state, we've had at least a handful of warrant article initiatives brought up in local towns to try to go back to hands counting for machine counting. I think one of them passed, but normally that doesn't happen. People seem to really think the machines are the way to go, and yet you guys, in your own experience, have seen repeatedly that these are problems.

Well, when the ballot law commission and the secretary of state held testing for the public to come and actually look at the machines, that was probably what, year and a half ago, Tom and I went down and we independently filled out ballots on our own with different scenarios in order to test whether or not they would work properly.

Yeah buddy, you're inevitable.

Ken (07:05.589)

We both independently made the machines produce fraudulent results. And we were only dealing with like what, 12 or 15 ballots each.

Tom Murray (07:10.835)

Yeah.

Tom Murray (07:15.335)

Yeah, yeah. I had the Dominion machine and I think you had the voting works machine. yeah, yeah. And really what that goes back to is the whole audit.

Ken (07:21.109)

Yeah, I did them both.

Ken (07:27.696)

There was a third one there too. I forget which one, what company that was, and then they withdrew.

Tom Murray (07:34.963)

That's right. There was a third company there, but this goes back to the audit, Ken, where, you know, they proved that it was a function of the machine's inability to decipher a fold through the target oval and an actual fill that oval, which disenfranchise voters. And it didn't just happen in Winn-Him, New Hampshire. And that was the unfortunate part of the audit is the audit never went far enough because I submit.

If it did, and you looked at the data, which we clearly had, we had almost every single tally tape from every machine in every voting district in the 2020 election. And clearly you could see inordinate amounts of overvotes. Actually, it was Ken that worked with a group of people that fixed that by creating a law that that ballot, your ballot would be spit back out of the machine for you to go ahead and either fill out a new ballot.

or put it into the auxiliary bin, is the little side envelope on the side of the black box, which houses the voting machines, to be hand counted.

Yeah. And since that law was passed, if you look at the results coming out of all the polling places, overvoted ballots are close to zero. It's an unheard of almost that it ever happens.

So when you go and you look at, was it Merrimack, which I think is where you are, Steve, you got close to 22 % overvoted ballots.

Yeah.

Mayor Mennon.

in the 2020 election. I mean, that's just ridiculous that all of those voters were disenfranchised.

Yeah, the ironic part about that, Ken, was the fold actually went through the late Dick Hinch's target oval. And it actually disenfranchised Democrat voters in that time. So, you know, that was an area of interest because this really should be a nonpartisan issue, you know, but unfortunately people just didn't want to take the time to understand what the problem was. And here we are.

This is Einstein's theory of, or a definition of insanity. They keep doing the same things over and over again. You know, we file a complaint, the complaints are acknowledged.

that I'll show up.

We use, you know, this is not personal. This is we use all election official documentation. We point out the problems. We they get investigated. They get acknowledged. And then a whole series of of training takes place. They scoop the elections again. They point an election monitor. They still screw it up, even with an election monitor present. We file complaints. They have more training sessions.

And the same people are running this. And now some people would come in and they'll say, well, yeah, yeah, yeah. But, know, Peter Griffin used to be the election monitor for Windham and he's no longer doing that job. But the person who was sitting in the elections in Windham in 2020, in every election forward, as the person who was actually tallying up the votes, creating the spreadsheet, sitting in the back, scratching his head until three o'clock in the morning on almost every election.

So 50 % more and yet,

Our election officials did a great job. How can that possibly be? I submit to you that we have people who work as election officials, who work for the state government. In fact, we have one guy who's a selectman. He works for the AG's office in the DCYF office as a prosecutor. And I think that helps. We have another guy who's an election official.

He hasn't served on the elections the past couple of elections. Maybe he got tired. Maybe he realized that there were problems and he just decided to bow out. But he is a significant donor to Chris Sununu, who says that we have the gold standard in the nation, which is a bunch of crap. And he's also, you know, good friends with the governor, shows up to ribbon cutting ceremonies and yada, yada, yada. Well, the monitor's report from this past election says that there were people who were counting every vote on the ballot, which means some of those races, probably most of them, were double counted. praise from the election monitor. What do you think that is? Why?

But anyway, the most recent problems in Wyndham where there were moderators who wrote a really nice report, which Ken just talked about, never once in that entire report did they mention what was probably the single biggest problem with the 2024 election in Wyndham. He was still back there after Aaron was done. He was still in the back trying to reconcile the election. Aaron was done. The announcement was made at about what, a three thirty ish, you know. So after all, all the the voters were counted, all the ballots were counted, all the votes themselves were counted. And the and the announcement, Aaron said that. Gannon was still in the back at four o'clock when she went home, trying to still figure out what was going on.

Tom Murray (33:03.044)

scratching his head.

Steve (33:26.859)

Wow.

Tom Murray (33:26.899)

And what they're trying to do in this current report is they're trying to get you to believe that, these are all new election officials. know, Peter Griffin has gone away. Nikki Merrill, the clerk, she has resigned. This is new. No, it's not. These are the same individuals that were there in 2020. They're the reason why. Yeah.

Ken (33:37.079)

They're not.

Ken (33:51.893)

and any subsequent election after that.

Tom Murray (33:55.185)

And there's a group of people that stand around these individuals and they don't hold them to account. In fact, they do just the opposite. They shield them from any real criticism and accountability. Yeah. Yeah. He carnivores. Yeah.

Ken (34:06.785)

like Keith Partington, like Keith Partington, publicly phrases them, publicly condemns Ken and Tom, privately admits there have been problems.

Steve (34:16.844)

Yes, publicly publicly condemns you for caring about which 197 voters didn't get counted because or did they? We really don't know. And that's every freaking election.

Ken (34:27.339)

We don't know. And yet, where's the investigation?

Tom Murray (34:31.847)

Right. So to give this some context, because I think this is important, in the primary, there is an issue and it's up in the courts. It's in the Richards case against Sununu, which has been kicked back down to the lower courts. But one of the things that the state statutes are clear on, it's RSA 65950B. And it basically states that

Anyone that is submitting an absentee ballot has to have an affidavit. We all know that the definition of an affidavit is an instrument that has to be attested to in the presence of a person who's authorized to administer an oath. That being a justice of the peace, a notary or in the elections, an election official. That was happening.

all the way up until 1979. And what happened in 1979 was, and what I think is a clerical error. We had the legislature go ahead unconstitutionally change our Article 11 Constitution by adding religious exemption to the ballot affidavit. Now, Dave Scanlon and I have a disagreement.

Dave believes that RSA 657, the affidavit stands on its own. And I disagree because I say election procedure, which is chapter 659 dictates and 659 defines affidavit. 65950B says that it has to be sworn and attested to. And moreover, to add to my argument, 65953 states,

Forms not in order if it's not notarized then it's not supposed to be counted. In fact, the quote is affidavit not properly executed end quote. So this is a controversy that many people like agree with within my position and Dave disagrees, which is fine. So what

Ken (36:45.079)

Dave Scanlon, I just want to make it clear, is the Secretary of State of New Hampshire.

Tom Murray (36:51.249)

Yes. Thank you, Ken. And so the secretary's and state, we've talked about this, we've discussed this. So I thought, here's an ingenious idea. Let me use RSA 659-27A, which states that if I'm a registered voter, I can challenge that ballot that I believe to be defective. And I did that because it wasn't duly attempted to. So I did that in the primary.

because it wasn't really attested to by law.

Tom Murray (37:20.893)

So I don't think Dave Scanlon really appreciated that. And I don't think he liked it. Okay. And I think that's what prompted that letter that came out prior to the election, that memorandum, okay, which I also disagree with. Not only do I disagree with that memorandum, I think it's a violation of federal code. And I think it's influencing voters unlawfully.

It's amazing because I've, I've, you know, been a little bit more involved in this. know, obviously we were very involved in the 2020 incident and everything that followed from that. Because you guys both contribute to GraniteGrok and we were very happy to continue to promote that out into the universe. But just, you know, having people from the attorney general's office send me emails explaining something legal to me, and I'm looking at it and going, this is total bullshit. This isn't what it says. You can't do this. I just

These are the people responsible for enforcing the constitutional law of the state of New Hampshire.

Tom Murray (38:25.341)

Well, I'm gonna share, yeah. So this is interesting. we get to Election Day on November 5th, right? And this memorandum kinda hits some nerves with some people. One of those individuals is former Supreme Court Justice Bob Lynn, who also happens to be a Wyndham representative. And I'll get to the conversation in a minute between him and Brendan O'Donnell that took place

That's the same point I'm making. They're not forcing the laws.

Tom Murray (38:54.713)

on Election Day. So the night before the election, I took the time to go out to the polling location and film and take photographs of the warrant that was posted in any postponement of absentee ballots. So just so that your audience is aware, by law, RSA 65949, you are supposed to begin processing all absentee ballots at 1 p.m. on Election Day.

Okay? Anything that comes in after 5 p.m. is not supposed to be counted, but you're supposed to start the processing of absentees by 1 p.m. However, there is a state law that allows for 10 or more individuals who are registered voters on the supervisor's checklist to postpone at the end of closing. Now Ken and I have gathered some of these, you know, individuals in the past.

because we saw a problem with Windham, continuing problem, was they were having difficulty processing the absentee balance accurately. So why don't we exercise this law and make it so that they can go ahead and process these at the end of the night. So their focus can be all on the accuracy of these absentee ballots, because even in the 2020 report,

I can't remember how many, but there was a significant amount of people that were disenfranchised because their ballots weren't counted.

Ken (40:29.947)

Let me just jump in again, Tom. I'm sorry. So we did this, filed this, what do they call it, a challenge. We had more than enough people sign it to delay the processing of the absentee ballots until after the polls close. It only takes them about 50 minutes to actually process all the ballots, open them up out of the envelopes, check them off on the checklist, put the ballots in the machines, and they're done.

Tom Murray (40:31.761)

Yeah, go ahead.

Ken (40:59.479)

It's only about 50 minutes, but we did this two or three elections in a row. And again, those election officials who like to poo poo Ken and Tom, they're publicly saying, well, we caused the elections to go until 3.30 in the morning. And what bad people we are. We're not considerate of the volunteers who are coming. Everybody's getting frustrated. And what disruptors we are. Well, this past election, the general election,

We didn't file that challenge. You know what they did? They took it upon themselves to wait until after the polls closed to process the absentee ballots. I just, you can't make this stuff up. We're bad guys for telling them that that's a really good organized way to do it. And yet when we don't tell them that that's what they should do, they do it themselves anyway. And they do it in violation of the law because they did not post.

24 hours in advance that that's what they were going to do and that's the point that you're making Tom.

Tom Murray (41:58.941)

That's the point, and I'm gonna further it by saying Kristen Martino, that was the monitor. I told her, I said, first and foremost, the posting is defective because it's not up there. Okay, so you're not supposed to count at eight o'clock. They should be counting there right now at

1 p.m. She's like, we're gonna call the AG's office. And guess who answers the phone, Brendan O'Donnell. And what does Brendan say? Brendan says, it's okay to violate the law.

because there is no provision for them to count at eight o'clock on their own. But we're going to go ahead because they posted online and they posted at the clerk's office. But that's not what it says, Brendan. It says shall. It says shall. So you're authorizing the monitor, Galen Stearns, to neglect his duty, violate people's rights, violate the law, and not follow that properly. that's just one issue out of many.

Okay, I want to get back into the point where you're making where I'm challenging these absentee ballots for being defective. The very first one I challenge, Roger Hollenberger, the selectman, is throwing a tizzy, having a fit. Okay, now this absentee ballot is not signed. It doesn't have a signature on it. And everyone knows that's the kiss of death on an absentee ballot. If it's not signed, not to Roger, not to Roger.

Not to Roger.

Tom Murray (43:26.373)

Roger wants to count it and he's throwing a fit and and and I don't understand why these people just don't understand the rules of the game and how elections are conducted and after all of the monitor reports and all of the news media attention not portraying these people in a positive light why would they just none of these people by the way

Ross McLeod, Selectman, Roger Hollenberger, Heath Parniton showed up at the mandatory training that was given by Dave Scalen, the Secretary of State. None of them. None of them. Bruce Breton also couldn't conduct, but I'll give him a pass because he was in the hospital. He had a heart attack. So.

He had medical issues. And if you're going to name names, the fifth selectman, Mark Samsel, was actually there.

Tom Murray (44:24.231)

Mark Samsel was present, he was. And I applaud Mark's to try, but here's the thing, and Mark's a good friend of mine, but I'm gonna call him out on this show too. Mark's gonna do a better job, because the results are the results, and the cast ballots are off by 197. Now,

Well, yeah, because the Constitution states that the count, the processing and counting of votes shall be done in the presence of the selectman whose duty it shall be to observe and witness and confirm the accuracy of the votes. Yeah. They're not doing that.

the meeting where Tom became aware of that letter, the email that Heath Partington wrote. Tom brought up that they were off between the number of ballots cast and the number of voters. And Galen Stearns admitted that he knew that on election night, but he went home anyway. He didn't want to stay and reconcile it. And that's exactly what the

cease and desist.

The cease and desist letter to Exeter back in 2019 specifically said you should have stayed at the polls. You were off by 110. You should have stayed at the polls until you reconciled it. That number is not acceptable. That difference, that discrepancy, it must be reconciled before you go home.

People need to understand it in a lot of towns in New Hampshire. That's a huge number. mean, elections are won by one or two votes, which is why we focus so much on get out to vote. Why, especially at town elections where maybe 15 to 20 % of the actual population that can vote shows up to vote on school budgets and town budgets. You're talking about a handful of votes, maybe on everything, depending on what it is. And so 197 votes is huge.

This has been in every single election.

Ken (46:23.447)

Hold on. A couple years ago, Senator Bob Guida, he's retired now, but Senator Bob Guida put in a bill, an election law bill, and in his presentation to the Senate, he made the statement that over the past, I think, 44 or 45 years, there had been 44 or 45 elections decided by one or less votes.

to the point that you're making, Steve, it happens almost every election.

Tom Murray (46:57.107)

To add to that Ken, we had, and I believe it was a local election in 2023 or was it 22, it was a Julia Sote House race, which he was declared the winner. And then subsequent to the four o'clock deadline to ask for recount, and keep in mind, he's declared the winner. Over the weekend, he was declared that he didn't have enough votes.

## Ken (47:25.495)

They recounted the votes in secret in violation of the law. They submitted new, quote, final results to the secretary of state. I think they took 17 votes. There was a 17 vote swing between Julius and the person he was running against. And it was such a close race that at that point, Julius was declared the loser of that race.

There was a recount because it was so close. Julius' opponent asked for a recount on that Tuesday morning. If that opponent would have said, I don't want to have a recount, the results would have stood. Julius would not have been deemed the winner of that race. And, you know, fortunately the recount proceeded, the, Julius' opponent wasn't aware of it.

And the recount actually flipped back the votes to something very, very similar. I think it was off by one on election night and Julius was declared the winner. But, you know, these are the types of things that were in our complaint. And when we, when we point them out, the response of the, Brandon O'Donnell in his report was that the

No results of any race change. Yes, they did. They did. The results of Julius Soti's race, think it's Rockingham County District 35, they changed. They changed from Julius losing, from winning to losing, and then winning again. And the only reason why he won again is because of the recount. But the results were off and they're flawed.

Nobody in our AG's office appears to care that we have people down here who can't do second grade math. And I'm using that term not to belittle, but if you think about it, you've got three, you've got, in Wyndham we've got four voting machines and each voting machine produces results in the thousands of votes, okay? So you've got four digit numbers. Second graders learn how to add four digit numbers together, but.

The people who are doing that or the person who's doing that and win damn, it takes them hours and hours, five, six hours after an election. Even using a spreadsheet where all you have to do is transcribe the numbers from a voting machine on eTrace into the spreadsheet

where it automatically adds up all the machines, ripples down and gives you the totals. Yet they can't do that. Something's seriously wrong.

Tom Murray (50:17.107)

And to go back to what I was explaining to give you the context of this December 5th report, on November 5th, Election Day, I went ahead and as I did in the previous primary challenge these defective ballots, I challenged the defective ballots again. And interestingly this time, in that memorandum,

it's not only about where to place your ballot, it's also about ballot challenges. And it was labeled mass ballot challenges by the Secretary of State's office and the AG's office that the moderators weren't to accept those. So I had duly lawful challenges to these defective ballots. And they were in the thousands, by the way. And

my rights were violated RSA 65927A was very clear on the statutory process that you're supposed to follow and I followed it to a T and I have them on video telling me that they will accept my challenges but they're not going to process them. Now I had to sign these in the presence of an election official

because I have to sign an affidavit, Steve.

But the election official wouldn't sign that he witnessed Tom signing them.

Tom Murray (51:49.553)

Yeah, go figure. To challenge, you have to produce an affidavit, but they don't enforce the affidavit that you're supposed to sign in order to vote.

And the monitor said that he will sign as witness after the fact based on the word of the person who actually witnessed. The monitor was supposed to be the guy actually witnessing so that he could sign and attest to Tom's challenge.
